Rowdy Goings-on in Stewkley 120 years Ago

A recent adventure through the archives of local newspapers turned up a report dated Saturday 6 May 1899 in the Buckinghamshire Advertiser and North Bucks Free Press of rowdy behaviour in the village.

Thomas Dickens and George Alder, both Stewkley labourers, were summoned by William Elmer, beer-house keeper, for being disorderly and refusing to quit his licensed premises when requested to do so on 17 April.

As complainant he stated that he kept the Plough Inn beer-house in High Street North, Stewkley. On the night of 17 April, the defendants came to the inn and wanted to 'fall out' with the complainant's father. They kicked up a disturbance, threatened the family, and Dickens knocked over a quart of beer, threatening to break the clock or the lamp. They refused to leave, and challenged other young men who were enjoying the Plough's hospitality, to a fight. They refused to leave even at ten o'clock and remained until 10.15. They claimed not to be drunk, but had been at work all day, and were dissatisfied with their treatment. Miss Elmer, sister of the complainant, corroborated.

The Magistrates' Bench imposed a fine of 10s. and 8s.6d. each costs, or seven days imprisonment.

Thomas Dickens was further charged with assaulting Mr Elmer on 18 April. The complainant claimed that on the evening following the earlier offence, he was returning from Leighton Buzzard and pulled up

at The Swan Inn when Dickens came running out like a madman. He demanded of the witness (Elmer), "What do I owe you?" Witness replied, "Eighteen pence", and the defendant retorted, "I shan't pay you!" and struck the witness.

A young man came out of the Swan and stopped him striking the witness further. The defendant attempted to climb onto the shafts to pull the witness out of the trap, and the witness hit him with his whip as hard as he could. The defendant picked up some stones and threatened to kill the witness, and later on came to the Plough Inn and again made a great disturbance, knocking another man about, slapping Miss Elmer's face and breaking a window and a flowerpot. The defendant claimed not to be drunk but excited.


The Chairman of the Bench remarked that the complainant got the best of it, having knocked the defendant down. The fine was set at 10s. and 7s.6d. costs or seven days in jail.

George Alder, labourer of Stewkley, was further charged with using obscene language on 18 April. He did not appear before the Bench and Police Constable Cooper proved the case, defendant being fined 2s.6d.and 7s.6d. costs or seven days imprisonment.
